Consent Form for Personal Data Collection

- Period: 3 years (Personal data may be retained for as long as it is necessary to fulfil the purposes for which they were collected, or as required or permitted by applicable laws.)

4. Disposal of Personal Data

- Procedure: Collected personal information is destroyed after the end of the retention period in accordance with relevant laws and regulations.
- Method: Electronic data is permanently deleted and physical data is shredded.

5. Transfer of Personal Data
